In the area of intellectual property, Ms. Mazanitis represents clients in a variety of matters, including utility, design, and pharmaceutical patent infringement; copyright infringement; trademark infringement, unfair competition, and counterfeiting; trade dress infringement; trade secret misappropriation; defamation; and the federal computer fraud and abuse statute. Ms. Mazanitis has litigated disputes in federal courts across the country, and in trademark opposition and cancellation proceedings before the Trademark Trial and Appeal Board.
